## Program Admission Requirements

  - Submitting an application for admission does not guarantee entry into your program.
- Submit official transcripts (high school and other colleges)
- Complete Background Information Disclosure form.
  - The Wisconsin Caregiver Program responds to the potential for physical, emotional and financial abuse of vulnerable citizens by persons who are entrusted to provide care. The Caregiver Law is intended to protect persons from physical harm and misappropriation of property. The Lakeshore College District is subject to the requirements of the Wisconsin Caregiver Program. In addition, the Lakeshore College District has a public interest obligation to assure that all students, engaged in clinical practice and law enforcement tactical programs, may be safely permitted to have contact with patients and children in a caregiver role, as well as contact with tactical equipment. Sections 48.685 and 50.065 of the Wisconsin Statutes require all students to complete a background check before participating in a clinical or practicum requirement that involves contact with patients or children in a caregiver role. In conformance with applicable law, the Lakeshore College District will collaborate with local health care, child care and law enforcement agencies to closely examine the results of background information disclosures. Pending charges and convictions may disqualify students from specific course work and programs for the reasons set forth above. Section A.1. of the Background Information Disclosure form requires you to disclose all pending charges and convictions. This includes pending charges, as well as conviction of a felony, misdemeanor or municipal ordinance violation, in any court, including all military courts, or a tribal court. If you are uncertain as to whether a pending charge or conviction is covered, disclose it. Convictions and pending charges are reviewed on an individual basis with respect to impact upon admission to programs. Failure to disclose a charge or conviction will prevent program admission or result in dismissal proceedings, as appropriate, subject to program requirements. All convictions and pending charges are examined, with final decisions based on the specific nature and circumstances of each charge or conviction, and the correlation to clinical, practicum, and tactical programs.

### **Attendance**

Students are expected to attend all EMS classes. All instructional hours missed need to be made up and approved by the course instructor. Make-up assignments will be of sufficient quality to provide the student with the essential information of the instructional period missed. The total absences and events of tardiness **shall not exceed those specified in that specific course syllabus**; exceeding those specified in the course syllabus will lead to a failing grade in that course, and inability to advance on to the subsequent course in the program.

### **Academic Rigor**

All Paramedic and General Education courses are Associate Degree level courses. As such, the instructors need to meet certain requirements and the academic rigor must meet certain requirements. These requirements allow these Associate Degree credits to be transferable into many Universities towards a Bachelor's Degree. Due to these requirements, the academic rigor is set that for every hour of in class instruction, the student should schedule two hours for out of class reading, studying, projects, and homework.

Student must receive a grade of a (C) or higher in all Technical and General Education courses to be considered as acceptable academically for their Program. Classes with grades below that of a (C) will require retaking until a grade of (C) or better is obtained.

### **Student Conduct Code**

Lakeshore College is an academic community that maintains high standards of instruction and provides a safe campus for all persons utilizing its programs and services. As a learning organization, Lakeshore monitors student conduct, encourages positive behaviors, and requires academic integrity in support of a positive teaching and learning environment.

Students are expected to maintain appropriate behavior when attending college classes and activities. If actions become disruptive to the classroom and/or to other learners, the individual(s) may be requested to leave the class or event. This includes behavior that may be disorderly, profane, unreasonably loud, indecent, or violent. ## **Program Expectations**

### **Self-Reporting Requirements**

Your program acceptance is tentative until confirmation is received by the college from the Department of Justice on your background disclosure information. From the time you complete the Background Information Disclosure form until you graduate from or drop the program, understand that if you are charged with or convicted of a crime or if you are investigated for any violation of a local, state or federal law, you must report this to the Lakeshore College Public Safety Dean within 1 day. Understand that (1) this investigation may result in your suspension from practicums which may delay or prevent your graduation from the program; and (2) your failure to report will result in your removal from the program.

### **Cellphone and Pagers**

Cellphones and pagers are not to be used during classroom time. Cellphones and pagers will be silenced and out of sight during any teaching time. Cellphones and pagers can be used during breaks. For any student that fails to comply with this policy, the first violation will be a verbal warning, second violation a written warning, and third violation will result in the student receiving a failing grade in the course. Any student needing their communication device due to an emergency should communicate this need with their instructor.

## **Appearance and Dress Requirements (EMT-Paramedic, Fire Medic and Paramedic Technician only)**

The approved student uniform is:

- Maroon Lakeshore College Fire Medic or Lakeshore College EMS Program uniform polo shirt. A white, black, gray, or navy blue long sleeve shirt under the uniform shirt for comfort is allowed
- The shirt will be neatly tucked in
- Navy Blue Lakeshore College Fire Medic or Lakeshore College EMS Program uniform sweatshirt
- No article of clothing can cover the uniform
- Navy blue or black EMS uniform pants with black belt
- Black duty boots (no tennis shoes or crocs allowed)
- Hats and headbands in white, black, gray or navy blue colors are acceptable
- Tattoos or piercings deemed inappropriate by Lakeshore College or clinical-site staff must be covered or removed.
- Hair that falls below the collar or over the face needs to be secured back or up
- Student must maintain a professional appearance and an appropriate level of personal hygiene at all times
- Wristwatch with digital seconds or second hand (a cellphone does not meet this requirement)

## **Personal Protective Equipment (Fire Medic only)**

Program expectations will require students to utilize Fire Service Personal Protective equipment. Students needing to utilize LTC Personal Protective Equipment will recognize that this equipment is the property of LTC and shall remain on LTC campus grounds. This equipment shall only be utilized by program students when performing activities as part of their responsibilities within the Fire Medic program. Individuals removing the property from campus or using the property for activities outside of the program activities will be subject to disciplinary action. Additionally, students with LTC issued equipment shall maintain the equipment in a ready to use state. Any concerns with the equipment shall be referred to your course instructor.

## **State Certification Standards (Fire Medic only)**

The Wisconsin Technical College System oversees the evaluation process for C=certification within the Fire Service. While Certification is not a required component of the Fire Medic Program, it is highly encouraged. Firefighter certification at the various

levels includes a computer based examination to be completed with a minimum score of 70%. In addition, a practical examination will need to be successfully completed. There is no fee for the computer based examinations. Practical examinations have a fee of \$80. Students are able to complete the certification exams at any of the WTCS campuses offering these examinations. Both the computer based and practical examinations must be completed within two years of completion of the coursework; failure to complete within this timeframe will require retaking the coursework to allow for certification. The testing process utilized by the WTCS has gained national accreditation through IFSAC (International Fire Service Accreditation Congress). This allows reciprocity with many states. To be eligible for testing and/or licensing in the state of Wisconsin, you may be required to obtain a social security number.

### **State Certification~ Re-testing (Fire Medic only)**

Students failing to meet the passing standard for state written examinations will be allowed two retests. A third failing grade on any state exam will cause the student to retake the coursework before being able to enter into the certification process again. Additionally, two retests of the practical skills exams are also allowed. Failing the practical skills exam a third time will result in the student needing to retake the course before being able to enter the certification process again.

### **WI EMS Licenses and Clinical Rotations (EMT-Paramedic and Paramedic Technician only)**

Once obtained, students will be required to maintain WI EMT licensure throughout the duration of the Paramedic program. Additionally, students will be required to obtain a WI Department of Health EMS Training Center Training Permit prior to beginning any clinical rotation. Students are not permitted to schedule rotations in clinical departments until approval from Lakeshore College faculty is granted.

I fail to present a copy of my Wisconsin EMT license to the Paramedic instructor two weeks prior to the start of Clinical 1, I will not be eligible to continue in the Paramedic program as possession of a Wisconsin EMT license is required to receive my Paramedic Training Center Training Permit for clinical rotations.

### **National Registry Certification Standards**

The National Registry of Emergency Medical Technicians oversees the evaluation process for Certification within the EMS profession. While Certification is not a required component of the Paramedic Program, it is highly encouraged. EMS certification at the various levels includes a computer-based written examination to be completed through a external testing center.

### **Instructor Email Response**

In today's world of electronic communications, we all want to get our questions responded to quickly. Instructors, however, have responsibilities beyond the course you are a student in, and have personal time. With that said, time management skills are very important in determining your success in the courses you take. Be sure to plan

ahead and set aside time each week dedicated to course work questions. Contact your instructors while on campus or allow a reasonable parameter for responding to emails such as 48 hours, Monday through Friday, during the semester. It is important to use your Lakeshore College email account, as instructors are not permitted to reply to personal email accounts.

### **Weather-Related School Closures**

In the event of school closings due to weather, instructors will contact the students via email regarding how to make up the course material missed. It will be the responsibility of the student to check his/her Lakeshore College email to learn about the plan for making up the missed course content. The course content could be made up in the form of rescheduling or other form of assignment depending on the learning objective.

### **Credit for Prior Learning**

Lakeshore College recognizes that students may have already accomplished certain skills and abilities and may award credit for prior learning. However, certain limitations exist for obtaining professional licensure (EMT/ Paramedic) that differ from obtaining an academic credential (degree/ diploma). If an individual seeks to transfer in coursework from another institution, Lakeshore College will assess the relevancy to this coursework and may/ may not award credit for prior learning for academic credential attainment consistent with our credit for prior learning policies.

If an individual is seeking to transfer in coursework for acquiring professional licensure, Lakeshore College recognizes and enforces an expiration on psychomotor skills competence. The individual will need to provide documented WI EMS training center competence in each skill. This psychomotor competence assessment must have occurred within the preceding 18 months from when the student will be entering/ re-entering the desired EMS course to fulfil the psychomotor requirement. If the timeframe is greater than 18 months, Lakeshore College will recognize the credit for prior learning for completion of an academic credential but will not recognize this for obtaining professional licensure; an individual seeking to obtain the desired professional licensure will need to repeat the associated psychomotor competency assessment(s).

### **Accommodation Services**

Accommodation Services partners with students and their instructors to develop accommodation plans that ensure equal access to participation in programs, services, and activities. These plans are voluntary, confidential, and outcome neutral.

### **EMT, AEMT, EMT-PARAMEDIC TECHNICAL STANDARDS**

---

Students enrolled in the EMT, AEMT, EMT-Paramedic Program should be able to meet the established technical standards identified below. The technical standards for the EMT, AEMT, EMT-Paramedic Program are reflective of those found in the EMT, AEMT, EMT-Paramedic profession.

- Ability to move or transport objects up to 125 pounds individually, and 250 pounds with assistance
- Ability to detect and respond to emergencies
- Students must have sufficient endurance, strength, mobility, balance, flexibility and coordination to perform client care activities and emergency procedures
- Students must have sufficient sensory (auditory, visual, smell, tactile) ability
  - Ex:
    - Ability to visually detect environmental hazards
    - Ability to detect equipment displays
    - Detect subtle differences through skin
      - Depth of veins and arteries, vibrations, pulse, temperature
    - Detect changes in skin color, temperature, swelling
    - Detect odors (gases, or potentially dangerous atmospheric conditions)

- Ability to move or transport objects up to 125 pounds individually and 250 pounds with assistance
- Ability to detect and respond to emergencies
- Students must have sufficient endurance, strength, mobility, balance, flexibility and coordination to perform client care activities and emergency procedures
  - Ex: while wearing a respirator

## Technical Skills Attainment

As part of your education through the Wisconsin Technical College System (WTCS), you will participate in a Technical Skills Attainment (TSA). This TSA is an evaluation of your performance at meeting the program outcomes.
